BURIAL RIGHTS MAY BE RE-ASSIGNED WITHIN A FAMILY (SUBJECT TO A TRANSFER FEE) PROVIDING SUCH CHANGES ARE CONDUCTED THROUGH THE CEMETERY OFFICE AND CONFORM TO THE RULES AND REGULATIONS OF THE CEMETERY DISTRICT. SUCH RE-ASSIGNMENTS ARE ONLY COMPLETE WHEN RECORDED ON THE MAPS AND RECORDS OF THE MANTON JOINT CEMETERY DISTRICT. (CALIFORNIA HEALTH AND SAFETY CODES: DIVISION 8, CHAPTER 2, ARTICLE 4, SECTION 8331). SHOULD A TRANSFER BE MADE WITHOUT THE CONSENT OF MANTON JOINT CEMETERY DISTRICT THE TRANSFER WILL NOT BE HONORED NOR WILL THE MONEY BE REFUNDED TO THAT TRANSFEREE.

The purchase price includes the price of the plot and endowment care only. The remaining costs are to be collected at the time of use.
GRAVE SPACE BURIAL RIGHTS MAY BE TRANSFERRED BACK TO THE MANTON JOINT CEMETERY DISTRICT AND THE PURCHASE PRICE OF THE PLOT(S) WILL BE REFUNDED. IF AFTER FIFTY (50) YEARS AND THERE HAS BEEN NO BURIAL OF HUMAN REMAINS AND THE DISTRICT IS UNABLE TO CONTACT THE OWNER LISTED IN THE DISTRICT'S RECORDS, THE MANTON JOINT CEMETERY DISTRICT WILL CONSIDER THE LOT(S) ABANDONED AND WILL APPLY TO THE SUPERIOR COURT OF TEHAMA COUNTY FOR THE BURIAL RIGHTS TO REVERT TO THE DISTRICT.
